Joe is also a former Rotary International student, having completed a one-year ex-



NEIGHBORHOOD PRO – SPRING GARDENING TIPS

Lubbers are out in full force - those nasty grasshopper type insects that just love plants in the lily family, among others. If they are more than 1-1.5 inches, insecticides will be of little use. The best way to get rid of them is to pick them off the plant & drop them in soapy water, which kills them.

Now that we'll be having consistently warm weather, the insects will be out in force, so start scouting your yard every week or so, checking for the presence of pests. In many cases, you can see the actual pests themselves. Or, you might see the following: holes in the leaves, black sooty mold, white or black specs, a white cottony-looking substance, stippling or discoloration of the leaves, misshapen leaf margins, a fine web-like substance – all of these are evidence that there is some type of pest feeding on your plants. IT'S VERY IMPORTANT THAT YOU IDENTIFY THE PEST BEFORE APPLYING A CONTROL PRODUCT. The pest could be an insect, a mite, a caterpillar, a fungus, or a disease. Control for all of these must be specific to the individual pest.


