It's easy to participate!

• Purchase a set of 10 white bags and candles for only \$10 (payable to Orwin Manor Westminster Association) from: Matt Daley, 3350 N Orange Avenue (next to the park), 407-247-3666; Susan Ellis, 1415 Buckingham Road, 407-973-8061, or Stephen Pategas, 1425 Berkshire Avenue, (east end across from park), 407-622-4886.

• Each set will cover a 50-foot wide property. Buy additional sets for wider or corner properties.

• Free sand available at the Park at Orwin Manor. Bring a hefty bag or pail.

• Fold down the top edge of each bag and fill with 1 1/2" to 2" of dry sand. If sand is damp do not place in the bags until the last minute.

• Place luminaries approximately five feet apart on top of the curb. Insert one candle firmly into the sand.

• Light the candles at 6 p.m. They will burn for approximately 6 hours.

• Stroll the neighborhood to enjoy the holiday glow.

If you will be away or are unable to display luminaries, please consider purchasing luminaries and asking your neighbor to light them. The neighborhood will appreciate it.

AROUND THE CORNER

ORANGE AVENUE TRAFFIC CALMING UPDATE

In October, the Florida Department of Transportation (FDOT) advertised a design contract to prepare final plans for an Orange Avenue lane repurposing (road diet). The project is funded for construction in fiscal year 2023. During the final design process there should be meetings with the Orwin Manor neighborhood followed by public meetings.

The concept includes an additional left turn lane from Orange Avenue onto Orlando Avenue, lane reduction to two travel lanes with a center turn lane, bike lanes, and a midblock crosswalk with a rapid flashing beacon.

The current concept plan is not set in stone. We should be able to provide input on the typical cross section of the road, location of the mid-block crosswalk, removal of trees, etc.

The roundabout at Clay and Wilkinson is a separate project and will be designed later with public input and funding to follow for ROW acquisition and construction. The FDOT concept shows no impact on the historic Orwin Manor gates.

NEIGHBORHOOD BITS SANTA CLAUS IS COMING TO TOWN!

On Thursday, Dec. 17 at 6 p.m. at The Park at Orwin Manor, Santa will arrive with Mrs. Claus and elves on a sleigh escorted by the police and fire trucks! McLaren, a specialty auto dealer is proposing a dealership there. The Comprehensive Plan does not allow that use and the Orwin Manor Westminster Association Board voted to not support the request due to its inappropriateness. City staff does not support it and the Planning and Zoning Board voted unanimously to reject it. NEIGHBORHOOD PRO – DECEMBER GARDENING TIPS BY BOARD MEMBER & ORANGE CO. MASTER GARDENER PENNY POTTER

As I write this, we are finally having some real winter weather, even though it is Florida-style winter. The best way to find out if a plant will be damaged by cold is to find out from what part of the world it is native (assuming you know what the plant is!). If it is a tropical, it may need some protection from temperatures below freezing. Use a cloth covering – NOT plastic – which must go all the way to the ground, and be secured all around the plant so as not to blow away if there is wind. Or you can use a large cardboard box over the plant, making sure it's not bending the branches. The covering should not be left on the plant for more that a day or two. For really cold sensitive tropicals, you can put a light under the covering, to raise the temperature a few degrees. Make sure that the light won't burn the covering! If a plant is damaged, it's likely that it will come back, once the weather warms up. It's important not to prune any of the dead portions until mid February, or until the threat of another freeze is over.
